AUDIT COMMITTEE MEETING MINUTES

I. Call to Order – Chair Tony Jake

 Chair Tony Jake at 3:02pm. Roll Call followed. Members and guests could be heard clearly. Quorum met.

II. Approval of Meeting Agenda

Schrager moved; Fulton seconded. Motion carried.

III. Approval of Minutes of Previous Meeting

VI. Action Item

A. Approval of FY2022-2023 Form 990

Alison Johnson and Rachel Tattrie introduced themselves and thanked the attendees for the opportunity to present. Alison expressed her appreciation for Cherisse's assistance and emphasized the pleasure of working with cooperative clients.

Presentation of Form 990

Alison shared her screen to display Form 990 and explained its significance for public transparency and compliance. She provided a detailed walkthrough of the form, covering the summary page, mission description, program service accomplishments, IRS compliance, governance policies, and financial statements. She highlighted key sections such as the summary of the organization's mission, employee count, volunteers, expenses, revenues, assets, liabilities, and governance policies, including conflict of interest and whistleblower policies. Alison also explained the statement of revenue, statement of functional expenses, balance sheet, and the Schedule A public charity status test.

Discussion and Q&A

Sheree asked about the preparation date of Form 990 and its finalization. Alison confirmed the most recent updates and offered to send the finalized numbers. Sheree raised

concerns about the single audit requirement and its representation in the form. Alison explained the reasoning behind the responses and the implications of answering certain questions. There was a discussion on the inclusion of specific grants and the definition of pass-through entities, with Alison clarifying the criteria for listing grants. Tranitra emphasized the need for committee review and approval according to bylaws.

Approval of Form 990

Alison stressed the urgency of filing Form 990 by the deadline and mentioned the possibility of amendments if necessary. Sheree proposed a motion to approve Form 990 with a change regarding audit requirements. This was not accepted.

Tony moved to approve the FY22-23 Form 990 based on the auditors' recommendation, and Fran seconded the motion with a request for clarification on audit requirement language. The Form 990 was approved with opposition and abstentions noted.
